MESSAGE

NAVPHIL 070/20 - SOUTHERN PHILIPPINES, MINDANAO IS. - PORT PROTOCOLS

IN CONNECTION TO THE EFFORTS OF LOCAL GOVERNMENT UNITS TO CONTROL THE SPREAD OF COVID-19, THE FOLLOWING RULES ARE BEING IMPLEMENTED AT THE PORTS IN THE PROVINCES AND CITIES OF MINDANAO:

- I. RESTRICTIONS TO MOVEMENT OF PEOPLE
 - A. PASSENGER VESSELS, ESPECIALLY THOSE COMING FROM MALAYSIA, AND NON-CONVENTIONAL VESSELS ARE PROHIBITED FROM ENTERING ZAMBOANGA CITY FROM 16 MARCH 2020 AND WILL BE IN EFFECT UNTIL FURTHER NOTICE. OUTGOING PASSENGER VESSELS ARE ALLOWED TO DEPART ZAMBOANGA CITY.
 - B. FOREIGN AND DOMESTIC VESSELS, EXCEPT THOSE CARRYING CARGOES OF BASIC GOODS AND NECESSITIES, ARE PROHIBITED FROM ENTERING THE TERRITORIAL WATERS OF SURIGAO DEL NORTE PROVINCE FROM 01 APRIL 2020 UNTIL FURTHER NOTICE.
 - C. INTER-ISLAND BOATS OR VESSELS; EXCEPT THOSE CARRYING FOOD, MEDICINES, AND MEDICAL SUPPLIES AND EQUIPMENT; ARE PROHIBITED FROM TRAVELING TO AND FROM THE MAINLAND AND THE ISLANDS OF SIARGAO, BUCAS GRANDE, AND DINAGAT FROM 01 TO 14 APRIL 2020.
 - D. DOMESTIC PASSENGER VESSELS ARE PROHIBITED FROM ENTERING AGUSAN DEL NORTE FROM 18 MARCH 2020 UNTIL FURTHER NOTICE.
 - E. DOMESTIC PASSENGER VESSELS FROM PORTS LOCATED OUTSIDE SURIGAO DEL NORTE ARE PROHIBITED FROM DOCKING AT ANY PORT IN DINAGAT ISLANDS PROVINCE FROM 18 MARCH 2020 UNTIL FURTHER NOTICE.

- F. ENTRY OF PERSONS TO RESPECTIVE PROVINCES AND CITIES IN MINDANAO ISLAND ARE PROHIBITED EXCEPT HEALTH WORKERS, AUTHORIZED GOVERNMENT OFFICIALS, PERSONS WHO ARE TRAVELING DUE TO MEDICAL AND HUMANITARIAN REASONS, AND OTHER PERSONS AUTHORIZED BY LAW. THE FOLLOWING ARE THE DURATION OF SAID PROHIBITIONS FOR EACH PROVINCES AND CITIES:
 - 1. ZAMBOANGA DEL NORTE PROVINCE: 17 MARCH TO 14 APRIL 2020
 - 2. ZAMBOANGA DEL SUR PROVINCE: 19 MARCH 2020 UNTIL FURTHER NOTICE
 - 3. ZAMBOANGA SIBUGAY PROVINCE: 17 MARCH 2020 UNTIL FURTHER NOTICE
 - 4. SURIGAO DEL SUR PROVINCE: 20 MARCH 2020 UNTIL FURTHER NOTICE
 - 5. MAGUINDANAO PROVINCE: 17 MARCH 2020 UNTIL FURTHER NOTICE
 - 6. DAVAO REGION: 04 TO 19 APRIL 2020
 - 7. MISAMIS OCCIDENTAL: 02 TO 14 APRIL 2020
 - 8. MISAMIS ORIENTAL: 24 MARCH TO 11:59 PM OF 14 APRIL 2020
 - 9. ILIGAN CITY: 19 MARCH 2020 UNTIL FURTHER NOTICE
 - 10. SARANGANI PROVINCE: 19 MARCH 2020 UNTIL FURTHER NOTICE
 - 11. LANAO DEL SUR PROVINCE: 17 MARCH TO 14 APRIL 2020
 - 12. CAMIGUIN PROVINCE: 13 MARCH 2020 UNTIL FURTHER NOTICE

II. RESTRICTIONS TO MOVEMENT OF CARGO

- A. CARGO VESSELS FROM PORTS LOCATED OUTSIDE SURIGAO DEL NORTE ARE PROHIBITED FROM DOCKING AT ANY PORT IN DINAGAT ISLANDS PROVINCE FROM 18 MARCH 2020 UNTIL FURTHER NOTICE.
- B. VESSELS ARE ALLOWED TO UNLOAD AND LOAD CARGO AT ANY PORT IN MINDANAO ISLAND. HOWEVER, CREW MEMBERS OF SAID VESSELS WILL BE SUBJECTED TO APPLICABLE HEALTH AND QUARANTINE PROTOCOLS.

III. RESTRICTIONS TO FOREIGN VESSELS

- A. FOREIGN VESSELS, EXCEPT THOSE TRANSPORTING ORE FROM MINE SITES, ARE PROHIBITED FROM ENTERING AGUSAN DEL NORTE PROVINCE FROM 18 MARCH UNTIL FURTHER NOTICE.
- B. FOREIGN VESSELS ARE PROHIBITED FROM ENTERING DINAGAT ISLANDS PROVINCE FROM 18 MARCH 2020 UNTIL FURTHER NOTICE.

IV. RESTRICTIONS TO FISHING VESSELS

A. FISHING VESSELS WHICH ARE NOT REGISTERED WITH ANY LOCAL GOVERNMENT UNIT IN DINAGAT ISLANDS PROVINCE ARE PROHIBITED FROM ENTERING DINAGAT ISLANDS PROVINCE FROM 18 MARCH 2020 UNTIL FURTHER NOTICE.

ALL SHIPS/WATERCRAFTS ARE ADVISED TO TAKE NOTE OF THE INFORMATION AND ABIDE BY THE RULES SET BY THE PHILIPPINE GOVERNMENT TO PREVENT THE SPREAD OF COVID19.

MASTERS OF VESSELS WISHING TO CALL AT ANY PORT IN MINDANAO ISLAND ARE ADVISED TO CONTACT THE PORT AUTHORITIES FOR FURTHER GUIDANCE.
