NAVPHIL 077/20 - VISAYAS ISLANDS, SAMAR IS. - PORT PROTOCOLS

IN CONNECTION TO THE EFFORTS OF LOCAL GOVERNMENT UNITS TO CONTROL THE SPREAD OF COVID-19, THE FOLLOWING RULES ARE BEING IMPLEMENTED AT THE PORTS IN THE PROVINCES IN SAMAR ISLAND:

- I. RESTRICTIONS TO MOVEMENT OF PEOPLE
 - A. ENTRY OF PERSONS TO RESPECTIVE PROVINCES AND CITIES IN SAMAR ISLAND ARE PROHIBITED EXCEPT HEALTH WORKERS, AUTHORIZED GOVERNMENT OFFICIALS, PERSONS WHO ARE TRAVELING DUE TO MEDICAL AND HUMANITARIAN REASONS, AND OTHER PERSONS AUTHORIZED BY LAW. THE FOLLOWING ARE THE DURATION OF SAID PROHIBITIONS FOR EACH PROVINCES:
 - 1. EASTERN SAMAR PROVINCE: 12 APRIL UNTIL 11:59PM OF 30 APRIL 2020
 - 2. NORTHERN SAMAR PROVINCE: 15 TO 30 APRIL 2020
 - 3. SAMAR PROVINCE: 15 APRIL 2020 UNTIL 11:59PM OF 30 APRIL 2020
 - B. NO SAIL POLICY SHALL BE ENFORCED OFF THE COASTLINES OF EASTERN SAMAR FROM 12 APRIL TO 11:59PM OF 30 APRIL 2020 EXCEPT THOSE ALLOWED UNDER THE IATF GUIDELINES.
- II. RESTRICTIONS TO MOVEMENT OF CARGO
 - A. VESSELS ARE ALLOWED TO UNLOAD AND LOAD CARGO AT ANY PORT IN SAMAR ISLAND. HOWEVER, CREW MEMBERS OF SAID VESSELS AND DELIVERY PERSONNEL WILL BE SUBJECTED TO APPLICABLE HEALTH AND QUARANTINE PROTOCOLS.

B. FISHING ACTIVITIES ARE ALLOWED OFF THE COAST OF SAMAR PROVINCE.

MASTERS OF VESSELS WISHING TO CALL AT ANY PORT IN SAMAR ISLAND ARE ADVISED TO CONTACT THE PORT AUTHORITIES FOR FURTHER GUIDANCE.
